Welcome to a brand new and very exciting decade at the Arts Center. We finished 2019 with a bang! Our 22nd annual Festival of Wreaths was a success – we met our goal of \$20,000 even though we had fewer wreaths this year. Thanks to all of you who donated wreaths, bid on wreaths, and/or volunteered at the event.

As we enter the new year, we are finding creative ways to program the 2020/2021 season while in the midst of a theatre renovation. We have raised almost \$40,000 of our \$60,000 match so far. A big thanks to all of you who have made contributions! We still have some work to do to raise the remaining \$20,000. The renovations are scheduled for May, July/August, and November of 2020. Please pardon our dust while we make these improvements. We've picked out paint colors and carpeting so it's starting to get to the exciting part of the process. Stay tuned for the Season Pass announcement on June 1st!

We are also working on a brand new website (at the same address) with a cleaner design that will be more functional, versatile, and user-friendly. An enhanced calendar will make it easier to find specific performances, learn more about the event, and even download it to your personal calendar.
